The establishment of a jointly administered market at the tri-borderland between Afghanistan, China and Tajikistan holds significant potential for fostering peaceful and progressive development in the region. The linguistic and religious commonalities among the Pamir people provide a foundation for cultural understanding and cooperation, while the existing socio-cultural associations facilitated through the Aga Khan Development Network offer a framework for collaboration. However, it is crucial to address concerns regarding Chinese misconducts and malpractices in Xinjiang, particularly with respect to the treatment of local Muslims. By engaging in dialogue, promoting respect for human rights, encouraging economic development, and fostering international cooperation, the tri-borderland can become a catalyst for stability, inclusivity, and prosperity, benefiting the Pamir communities and the wider region. It is essential that all stakeholders work together to ensure that the jointly administered market promotes peace, respects diversity, and upholds the values of mutual understanding and respect.
